The applicant agrees that if it defaults on any outstanding balance and Stanwade Metal Products, Inc. incurs costs to collect this delinquent account, that the applicant will be responsible for paying these costs.

**Payment Terms:**

Visa, MasterCard and Discover (*3% convenience fee charged*) and C.O.D. shipments are accepted. Charge accounts may be applied for by buyers wishing to establish an on-going business relationship, by completing a credit application. Approved open charge account terms are Net 30 days.

**Freight Policy:**

Ordered items are priced F.O.B. shipping point. Freight charges will be added to the invoice. Our responsibility ends at the acceptance of the shipment by UPS, Federal Express or Common Carrier. Consignee must file a claim for shortages and damaged freight against the shipping company if it occurs. Inspections should be made, and any damage should be reported before the shipping company leaves the consignee's premises.

**Sales Tax:**

For our taxable customers with orders shipping to OH, PA, WV, MI, MD, and NY, we are required to charge sales tax by the SHIP TO state. For our customers who are tax exempt, we are required to have a Tax Exempt or Direct Pay Certificate on file. Otherwise, we are required to charge sales tax for that order. On orders going to all other states, our customer is responsible for all sales or use taxes that may be applicable.

**Warranty:**

All equipment sold by Stanwade Metal Products, Inc. is subject to a manufacturer warranty. Stanwade Metal Products will not allow claims for labor or consequential damage resulting from purchase, installation, or misapplication of the product. Restocking, freight charges, etc. will be the responsibility of the buyer.
